Background

• ICAID

Industry Connections Activity Initiation
Document

- ICCom oversees ICAID authorization
- ICAID are typically approved for two years subject to renewal application
- Renewal involves a non-negligible amount of bureaucratic activity
- In 2023, ICCom initiated an autorenewal process.

LMSC ICAID Issue

- 10.1 IEEE-SA standards board approval

An industry connections activity is authorized by the IEEE-SA Standards Board upon recommendation by the Industry Connections Committee (ICCom). ICCom requires the IEEE 802 LMSC to approve the Industry Connections Activity Initiation Document (ICAID).

10.2 IEEE 802 LMSC approval

A proposed ICAID and supporting documents shall be submitted to the IEEE 802 LMSC via the IEEE 802 LMSC email reflector for review no less than 30 days prior to the day of the opening IEEE 802 LMSC meeting of an IEEE 802 LMSC Plenary Session...

Ambiguity

• Since ICCom processes the autorenewal without input, there is no ICAID to be forwarded.

The LMSC OpsManual says:

ICCom requires the IEEE 802 LMSC to approve the Industry Connections Activity Initiation Document (ICAID).

Autorenewal is of an ICAID that is LMSC-approved.

• What's the role of LMSC regarding autorenewal?

Proposal

- The OpsManual ICAID material should be updated to address autorenewal.
- I propose that ICCOM autorenewal be authorized without LMSC action.
- Alternatively, I propose that 802 review be very lightweight.

Ideally, recognizing that even slight amendments could negate the autorenewal.

e.g. The ICAID asks for the "initial participants". There is no need to change this list on renewal. However, if we circulate the document, people will want to make a change.
